



## Paralympic Committee of India STC – Para Shooting

### NOTICE

- 1. The Novi Sad 2026 WSPS World Cup for Rifle/Pistol/VI, Novi Sad, Serbia (21–30 July 2026)** is being held as a **Level 2 International Competition** as per the **National Para Shooting Selection Policy 2026**. PCI is facilitating participation on **own cost basis** for eligible athletes.
- 2. Eligibility & Selection Criteria:** Selection shall be based on the score recorded across **National Para Shooting Selection Trial 1 and Trial 2, 2026 (NPSST 1 & NPSST 2)**, as per the **National Para Shooting Selection Policy 2026**. Athletes are requested to check their Score Statement till NPSST 1 & NPSST 2, 2026 before submitting their consent which is published on the website.
- 3. Consent Deadline:** All eligible and interested athletes are required to **submit their written consent by 15th June 2026 (Tuesday)**. Consents received after this date shall **not be entertained** under any circumstances.
- 4. Tentative Cost:** The tentative participation cost is approximately **₹3,90,000/- (Rupees Three Lakh Ninety Thousand Only) per person** on own cost basis, subject to final confirmation.
5. As per the National Para Shooting Selection Policy, every **03 Own Cost Athletes** will bear the **cost of 01 PCI Nominated Official** for various proceedings related to participation of Para Shooters.
- 6. Athletes are advised** to submit their consent in writing to the **Chairman, STC Para Shooting, Paralympic Committee of India** by email: [stcparashooting@gmail.com](mailto:stcparashooting@gmail.com).
- 7. PCI reserves the right** to take final decisions on team composition in accordance with the applicable Selection Policy and WSPS entry regulations.

## IMPORTANT NOTES

- i.** This event will be on an **own cost participation basis**. The approximate cost for the above said competition is **₹3,90,000/- (Rupees Three Lakh Ninety Thousand Only) per Pax**. To avoid any embarrassment from the LOC, kindly give your consent **only if you are ready financially**.
- ii.** Hotel accommodation cost has been calculated based on **double-occupancy**; charges **may increase in case single-occupancy** is opted.
- iii.** Lots of paper work and formalities are carried out at embarkation and disembarkation airports and competition venue. Para Shooters participating on own cost will have to **share the cost of one Manager/Coach/Official** on a minimum of **03 (three) shooters** basis. The said official shall be **designated by the STC — Para Shooting, PCI** after due approval.
- iv.** Athletes participating in the **Novi Sad 2026 WSPS World Cup** are required to submit an **Affidavit and Undertaking** stating that **PCI, STC — Para Shooting, and any of its Para Shooting Officials** shall not be held responsible in case of any issues during their participation.
- v.** **Air Fare, VISA, Insurance, Local Transport, Lunch and Dinner of PCI Officials** will be borne by all participating Para Shooters **collectively**.
- vi.** Entries and bookings for the **Novi Sad 2026 WSPS World Cup** are subject to the **discretion of the Local Organising Committee (LOC)**, Novi Sad, Serbia.
- vii.** Grant of **VISA for Serbia** is at the discretion of the **Serbian Embassy**.
- viii.** If applicable, **Entry Fee for Mixed Team Events and Team Events** will be paid by the shooter directly to the LOC in **Cash**, after discussion with the Team Coach/PCI Official at the venue.
- ix.** Participation will be subject to **confirmed Medical Classification by WSPS/IPC** at the Novi Sad 2026 WSPS World Cup.
- x.** All Para Shooters intending to participate are required to hold a **valid IPC Licence for the year 2026**.
- xi.** **Excess Baggage** cost will be borne by the Shooter.
- xii.** Cost of the **Playing Kit** will be borne by the Shooter.

**xiii.** After booking of Hotel, if a Shooter does not wish to attend the competition **OR** the Serbian Embassy declines the VISA — **no refund for Hotel, Transportation, Weapon Permit and Entry Fee is generally admissible.**

**xiv.** Other terms and conditions, and any changes in charges if applicable, will be **intimated in due course** as and when required.
